1. Call to Order

5. New Business

The definition of certain land surveying terminology was discussed to inform how such terminology may be utilized within exam items. Following previous LS committee discussion, Chair Noviello created a reference document offering an opinion on how the term should be utilized based a legal evaluation. This reference document will be added as an agenda item to the next Land Surveying committee meeting agenda, along with updates to the Survey Exam Reference list. The 2024 NYS Specific Land Surveying examinations will be held on March 22 and September 27.

A discussion was held on exam review/prep courses and CE credit and when attendance of such courses may qualify for CE credit.
