**Executive Session:** On a motion by Mr. Mertz and seconded by Ms. Singer, the Committee voted unanimously to enter executive session at 9:30 a.m.

**Minutes and Peer Review Determinations:** Based on a motion made by Mr. Neyman and seconded by Ms. Singer, the Committee approved the August 9, 2023, executive meeting minutes and peer review determinations.

**PRIMA Peer Review: NA** 

Dropped Firms -29 total - Firm Registration: 19 Current, 9 Delayed Registrations and 1 Not Registered.

Terminated Firms -1 total - Firm Registration: 1 Current, 0 Delayed Registrations and 0 Not Registered.

- a). Firms that require continued oversight: 16 firms will remain on the dropped monitoring list.
- **b.**) Firms that submitted a Form 6PR/6T to claim exempt that the firm is no longer performing attest services. No longer require oversight: 2 firms will be removed from the monitoring list.
- **c.**) **Firms that are reenrolled and no longer require oversight:** 5 firms will be removed from the monitoring list.
- **d.**) Firms that were dropped and no response was received. Referred to OPD and no longer require **oversight:** 6 firms will be removed from the monitoring list.

Firm A –The Committee briefly discussed the response from Beth Thoresen, Director of Peer Review Operations at the AICPA regarding the firm's peer review status.

**New Business:** Ms. Winters told the Committee Members that the Board ran reports in the Facilitated State Board Access. It resulted in follow up with firms being re-enrolled in peer review that were previously dropped or terminated. There was a discussion whether the firms were still offering/performing attest services while being dropped/terminated from the program. Additional follow up may be needed. Ms. Winters will be attending the upcoming NASBA meeting at the end of the month. This meeting will have a peer review update which Ms. Winters will report back to the PROC at the next meeting in February.

On a motion by Ms. Singer and seconded by Mr. Mertz, the Committee unanimously agreed to close executive session and end the meeting at 10:16 a.m.
