Mr. Iles brought to the Committee's attention that about a third of the firms that have been recently peer reviewed, have registration issues with NYSED. Ms. Winters pointed out that firms were not sent registration renewal forms in the mail by NYSED sometime during COVID and the Board Office was never told that this process was halted. Recently, the process of mailing out the firm registration documents has restarted. In addition, many firms have changed their address since the start of COVID and have not notified the Department within 30 days of the address change.
