Welcome and Review of the Agenda

Evan Seiden called the meeting to order at 10:10 AM. Board members and staff introduced themselves. New Board member Smita Bhatt was introduced and welcomed.

Review of the June 7, 2024, Board Meeting Minutes

The minutes of the June 7, 2024, Board meeting was reviewed. There were no changes made. A quorum of members was present. A motion was made and seconded to approve the previous meetings' minutes; motion was passed unanimously. Minutes accepted.

Executive Secretary's Report

Reviewed board office staffing. Executive Secretary reviewed production for Limited Permit applications is 8 weeks out, experience reviews are about 8 weeks out. Diagnostic Privilege experience reviews are 8 weeks out.

Board actively in the process of recruiting new members – looking for 1 LMHC or LMFT, and 1 Psychoanalyst. Nomination forms for potential Board members are being reviewed and additional candidates continue to be recruited. Board nomination forms can be found on the NYSED website.

Legislation and Regulation affecting Mental Health Practice: Mental Health Practitioners' Diagnosis Privilege (Chapter 230 of the Laws of 2022)

Executive Secretary Evan Seiden thanked stakeholders and staff for their continued efforts around implementation of the Diagnostic Privilege. Number of applications is increasing. Application process as well as review process moving along. Processing unit now taking phone calls Monday through Friday to assist applicants. Board members discussed education review Colleges and universities may be changing their programs to meet DP requirements; they are working with Professional Education Program Review (PEPR) office. Diagnostic Privilege FAQ is available on the NYSED OP website. Diagnostic Privilege forms are available on the NYSED OP website.

Applicants should email the Board Office with any questions on experience (Form 4D). Applicants will be notified if more information is needed during experience reviews. Copy of Operating Certificate for exempt settings is required to be submitted with Form 4D.

An FYI and review of an amendment of Mental Hygiene Law (Chapter 233 of the Laws of 2024)

Mental Health Peer, FPA, YPA, NYCPS, CYPA. An Act to amend the mental hygiene law, in relation to providing definitions of mental health and family and youth peer and requires the office of mental health to establish peer service qualifications.

Discussion: Tele-Supervision

Regulations to make tele-supervision allowed permanently were adopted and go into effect on 9/25/2024. Guidelines are being developed and will be posted in the future.

Other Business

Board members discussed proper advertising of DP credential for licensees. Professional entities with Diagnostic Privilege should consult Professional Corporations for assistance.

Next Board meetings are not yet scheduled. 2025 meetings not yet scheduled. Board members expressed desire for in-person meeting in June and for meetings to start later in the day.

NEW YORK STATE ASSEMBLY MEMORANDUM IN SUPPORT OF LEGISLATION submitted in accordance with Assembly Rule III, Sec 1(f)

BILL NUMBER: A701

SPONSOR: Gonzalez-Rojas

TITLE OF BILL:

An act to repeal paragraph (d) of subdivision 1 of section 7704 of the education law requiring applicants to pass an examination in order to qualify as a licensed master social worker

PURPOSE OR GENERAL IDEA OF BILL:

Repeals the requirement that applicants must pass an examination in order to qualify as a licensed master social worker

SUMMARY OF PROVISIONS:

Section one of this bill repeals paragraph (d) of subdivision 1 of section 7704 of the education Law requiring applicants to pass an examination in order to qualify as a licensed master social worker.

Section two sets the effective date.

JUSTIFICATION:

New York State is experiencing several simultaneous social crises - an increase of immigrants from Latin America, increasing homelessness, and a mental health and overdose crisis that is severely impacting many communities. Social workers will be the ones who deliver crucial services and 80% of them will be in our communities of color. To meet these challenges New York must have a large, competent, and diverse workforce of social workers because research posits that the most effective social workers speak the languages of their clients and reflect their experiences.

We must address barriers to expanding our mental health workforce, including barriers that prevent diverse social workers from becoming clinicians. For this reason, it is imperative that New York State license social workers at the MSW entry level who meet all New York State requirements for licensure other than the Association of Social Work Boards (ASWB) exam.

Per a 2022 ASWB Exam Pass Rate Analysis, in New York State only 49% of Black social workers and 63% of Latinx social workers pass the exam on their first try as compared to 86% of white social workers. This has resulted in fewer bilingual and social workers of color entering the workforce, including the mental health sector to meet the service needs of New Yorkers. Illinois and Rhode Island have already passed similar statutes because of the long history of racial disparities in the exam's pass rates. Additionally, the fees, humiliation, and salary and promotion implications for social work graduates are very burdensome. Due to the 2022 ASWB report, the National Association of Social Workers

released a statement in early February 2023 opposing ASWB social work licensing exams.

BILL NUMBER: A3906

SPONSOR: Bronson

TITLE OF BILL:

An act to amend the civil practice law and rules, in relation to extending confidentiality privileges to certain communications to or from a licensed mental health counselor

PURPOSE:

The purpose of the legislation is to include licensed mental health counselors among the professions for which confidential communication is provided.

SUMMARY OF PROVISIONS:

Amends article forty-five (45) of the civil practice law and rule by adding a new section four thousand five hundred and eight - a

(§ 4508-a). This new section extends the confidentiality provisions provided for licensed psychologists. (§ 4507) and licensed master social workers and licensed clinical social workers (§ 4508) to licensed mental health counselors.

JUSTIFICATION:

In 1968, the state recognized the need to protect the confidential communication beyond that of a medical professional. Expanding privilege to psychologists and social workers acknowledges that "Effective psychotherapy...depends upon an atmosphere of confidence and trust in which the patient is willing to make a frank and complete disclosure of facts, emotions, memories, and fears," Jaffee v. Redmond, 1996, 518 U.S. 1, 10, 116 S.Ct. 1923,1928, 135 Led,2d 337. The original law was amended in 2004 from "certified social worker" to "licensed masters social worker" and "licensed clinical social worker" in recognition of the protected scope of practice.

Licensed mental health counselors have a protected scope that includes psychotherapy and mental health counseling. Clients/patients seeking mental health services should know that their communications are considered confidential In the same manner provided for with psychologists and social workers.

- Deadline to complete is September 30th, 2025.


Where?
