**Executive Session:** On a motion by Mr. Wheeler and seconded by Mr. Neyman, the Committee voted to enter executive session at 10:10 a.m.

**Minutes and Peer Review Determinations:** Based on a motion made by Mr. Pitcher and seconded by Ms. Singer, the Committee approved the February 5, 2025, executive meeting minutes and peer review determinations.

## **PRIMA Peer Review:**

Firm A– The Committee briefly discussed the firm owner passing away but still being registered with the PCAOB. Ms. Singer noted that the firm must formerly withdraw from the PCAOB to become unregistered.

Firm B – The Committee briefly discussed the ongoing issues of the firm concerning the corrective actions that are past due. We will respond back to the firm's lawyer stating that we will continue to monitor the peer review until the hearing is completed and will hold the firm registration until the peer review issues are resolved as the last peer review was from 2022 and was the second failed peer review report.

Dropped Firms – 17 total - Firm Registration: 9 Current, 8 Delayed Registrations and 0 Not Registered.

- a). Firms that require continued oversight: 10 firms will remain on the dropped monitoring list.
- b.) Firms that submitted a Form 6PR/6T/6R to claim exempt that the firm is no longer performing attest services. No longer require oversight: 1 firm will be removed from the monitoring list.
- **c.**) **Firms that are reenrolled and no longer require oversight:** 2 firms will be removed from the monitoring list.

- **d.**) Firms that were dropped and no response was received. Referred to OPD and no longer require **oversight:** 4 firms will be removed from the monitoring list.
- e.) Firms that were dropped then subsequently terminated. Referred to OPD and no longer require oversight: 7 firms will be removed from the monitoring list.

The Committee used the 2/28/2025 date for the cut off for the following determinations for this meeting for the system and engagement reviews outstanding corrective actions.
