1. Call to Order - Executive Session

3. Education Proposal Reviews

The Education Committee is awaiting proposal review responses for two (2) new BS in Engineering and one (1) MS in Engineering programs. The two (2) programs recently approved by NYSED were covered in open session.

4. Waiver Requests

Three (3) waiver requests of the NCEES FE examination were reviewed by the Board, considering each applicant's education, experience, and existing out-of-state licensure.

<u>Motion</u> – Nogle/Mitchell: Grant a FE waiver to all three (3) applicants. **PASSED UNANIMOUSLY.**

5. New Business

- a. Further discussion around the circumstances, criteria, and making determinations for FE waivers will be held in a PE committee meeting (TBD). Continuing education may also be discussed.
- b. Artificial Intelligence (AI) position statements were shared for awareness.
- c. A PE Competencies draft was shared for awareness.
- d. A discipline-specific non-NCEES engineering practice exam formerly administered in another jurisdiction and an applicant's experience were discussed. Separately, ES will research state administered engineering practice examinations.
