**BOARD CHAIR REPORT:**

Dr. Morgante welcomed the two new board members Dr. Rita Capaccio and Dr. Ricky Cavallaro. Dr. Morgante stated it was his and Dr. Bruce Steinberg's last board meeting.

Dr. Morgante ended his report by saying that the purpose of the Chiropractic Board is to protect the public.

**EXECUTIVE SECRETARY REPORT:**

Dr. Calderon started his report by welcoming Dr. Capaccio and Dr. Cavallaro to the Chiropractic Board. Dr. Calderon informed members that the corrected Weight Loss Management practice alert was posted on the Op Chiropractic professional webpage and that the FAQ's are still with Legal.

54 Legislative Committee – Dr. Morgante, Chair, stated that the Scope Modernization Bill passed the NYS  
55 Senate, but that it did not pass in the NYS Assembly. Ms. Kellogg stated that NYSCA is anticipating the  
56 Scope Modernization Bill will be voted on by the NYS Senate and NYS Assembly at the next legislative  
57 session. Ms. Kellogg informed members that the Virtual Credit Card Bill passed both Houses and the  
58 Partnership Bill is still a work in progress. Dr. Ludwig, from the New York Chiropractic Council stated  
59 how the New York Chiropractic Council will be speaking about the IME Bill and the Non-  
60 Discrimination Bill at the Title 8 meeting.

62 Practice Committee – Dr. Handt Chair, stated that there is a new child abuse mandated reporter training  
63 course that needs to be completed by November 17, 2026, by all chiropractors in New York State.

65 Public Information Committee - Dr. Steinberg, Chair, stated that the Weight Loss Management Practice  
66 Alert has been corrected and posted on the OP Chiropractic professional webpage.

68 Outreach Committee – Dr. Taber, Chair, stated there is nothing new to report.

70 Program Review Committee (extension of the practice committee) – The Board discussed how a new  
71 Chair needs to be voted on.
